**Saturday, May 15 - Finals Round and Awards Presentation, Bass Performance Hall**

**Prizes:**

**First Place:** \$10,000 and a role in a Fort Worth Opera production within two years, pending appropriate repertoire

**Second Place:** \$5,000

**Third Place:** \$3,000

**Rick Berg Audience Favorite:** \$1,500

**Honorable Mention, Male:** \$1,500

**Honorable Mention, Female:** \$1,500

All semi-finalists will receive a \$250 travel stipend.

**Contest Eligibility:**

- Open to an international contingent of contestants
- Actively working toward a professional opera career
- Have not performed a contracted role with a Level 1 opera company
- Age: 21-35 male; 21-32 female

Up to 30 artists will be chosen from all completed applications to participate in the McCammon Competition.

**All artists will be notified of the results of the application screening on April 12, 2010.**

**Application Requirements:**

Eligible application packages must include:

1. A completed application form
2. Copy of driver's license, birth certificate or passport
3. Headshot and resume
4. Superior quality audition recording (CDs preferred)
5. \$30 non-refundable application fee

**Audition Recording Requirements:**

- Four opera arias representing contrasting styles and languages
- Piano or orchestral accompaniment (proof of permission to use orchestral recording must be provided)
- Recording must have been made within previous year
- CD recordings are preferred
- Recording must be labeled with the artist's name and track information
- All recordings become property of the Marguerite McCammon Voice Competition

- Former voice teachers and years of study

- Superior quality audition recording — CDs preferred, with any necessary release documents for orchestral recordings
- Copy of driver's license, birth certificate or passport
- Headshot and resume
- \$30 non-refundable application fee
